In consideration of the Banquet Hall allowing the use of its facilities for the event, the Event Host hereby agrees to release, waive, discharge, and hold harmless the Banquet Hall, its owners, employees, agents, and representatives from any and all liability, claims, demands, actions, or causes of action, arising out of or related to any loss, damage, injury, or death that may be sustained by any person or property as a result of the use of the External Vendor or the event in general, whether caused by the negligence of the Banquet Hall or otherwise.

#### 3. Indemnification

The Event Host agrees to indemnify, defend, and hold harmless the Banquet Hall, its owners, employees, agents, and representatives from any and all claims, lawsuits, or damages arising out of the Event Host's or guests' participation in activities involving the External Vendor or use of the banquet hall facilities.

#### 4. Third-Party Vendor Liability

The Event Host acknowledges that the services will be provided by External Vendor, an independent third-party vendor. The Event Host agrees that the Banquet Hall is not responsible for any actions, omissions, negligence, or failures of the External Vendor, including but not limited to the installation, operation, and supervision of anything during the event.

### 5. Compliance with Rules and Regulations

The Event Host agrees to ensure that all guests, including those using the External Vendor, comply with any rules and regulations set forth by the Banquet Hall or the External Vendor regarding the safe use of their services and the banquet hall facilities.

#### 6. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the state of Texas. Any legal action or proceeding arising under this Agreement shall be brought exclusively in the courts located in Collin County, Texas.

#### 7. Entire Agreement

This Agreement constitutes the entire understanding between the parties with respect to the matters addressed herein and supersedes any and all prior discussions, negotiations, and agreements, whether written or oral.
